Applicability

Applicable to service of one standard voltage requiring more than 50 kVA of transformer capacity, delivered at one point and metered at or compensated to that voltage. Service hereunder is subject to the established Service Rules and Regulations of the Corporation.

Type of Service

Single-phase or three-phase service, 60 Hertz, at standard voltages.

Minimum Monthly Charge

The minimum monthly charge shall be the greatest of the following:

- A. \$40.00 per meter, plus \$7.00 per kW of Billing Demand in excess of 10 kW, or
- B. \$1.25 per kVA or fraction thereof of transformer capacity supplied by the Corporation, or
- C. Contract minimum.

Line Extension Cost

The amount specified under the line extension and rephasing policy contained in the Service Rules and Regulations of the Corporation, such amount to be provided by the member in a manner specified in that policy.

Determination of Billing Demand

The Billing Demand shall be based on the highest 30-minute kW measurement in the current month and preceding 11 months.

For the summer months of June through September, the Billing Demand shall be the greatest of:

- A. The current month's measurement, or
- B. 90% of the highest measurement occurring in any previous applicable summer month, or
- C. The contract minimum.

For the winter months of October through May, the Billing Demand shall be the greatest of:

- A. 75% of the current month's measurement, or
- B. 90% of the highest measurement occurring in any previous applicable summer month, or
- C. The contract minimum.

Terms of Payment

Bills are due when rendered monthly. In the event the current monthly bill is not paid by the due date, the bill becomes delinquent.

Term of Contract

Contract term of service hereunder shall be based upon the investment required to provide service and the member's projected annual revenue.
