# Sumter Electric Membership Corporation Large Power Time-of-Use Service Schedule LP-TOU-10

#### **Availability**

Throughout the Corporation's service area from existing lines of adequate capacity.

# **Applicability**

Applicable to non-seasonal commercial and industrial members with a metered monthly minimum of 200 kW of demand for all uses including lighting, heating, and power. Service hereunder is subject to the established Service Rules and Regulations of the Corporation.

# **Type of Service**

Multi-phase, 60 Hertz, at available secondary voltages or at other voltages as might be mutually agreeable. Service under this rate will be provided with demand being measured through the use of metering equipment capable of determining the member's demand during any specific time interval.

D. WPCA - The above rate charges shall be increased or decreased in accordance with the Corporation's Wholesale Power Cost Adjustment Clause.

#### **Determination of Maximum Demand**

The Maximum Demand shall be the highest 30-minute kW measurement in the current month, but not less than the contract minimum.

#### **Determination of On-Peak Demand**

The On-Peak Demand shall be the average of the highest monthly 60-minute kW measurements during the on-peak hours in each of the four preceding months of June through September. The on-peak hours shall be the hours beginning 4:00 p.m. and ending 9:00 p.m. from June 1 through September 30 and will exclude weekends (Saturdays and Sundays).

This On-Peak Demand so determined shall be effective for monthly billing from January through December for the following calendar year.

# **Minimum Monthly Charge**

The minimum monthly charge shall be the greatest of the following:

- A. The sum of Service, Capacity and Energy charges as stated above, or
- B. A charge of \$1.25 per kVA or fraction thereof of required transformer capacity, or
- C. The charge as may be specified in the Agreement for Electric Service contract.

#### **Line Extension Cost**

The amount specified under the line extension and rephasing policy contained in the Service Rules and Regulations of the Corporation, such amount to be provided by the member in a manner specified in that policy.

# **Terms of Payment**

Bills are due when rendered monthly. In the event the current monthly bill is not paid by the due date, the bill becomes delinquent.

#### **Term of Contract**

Contract term of service hereunder shall be based upon the investment required to provide service and the member's projected annual revenue.
